Privacy Policy

1. General provisions and contact details

This Privacy Policy (the Policy) applies to personal data about You www.catecheticreativa.hu page content author, Áron Babos (the Author) receives and manages.

2. Legislation underlying data management

- Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation or GDPR)
- Act CXII of 2011 on the right to informational self-determination and on the freedom of information (hereinafter Infotv.).

3. Purpose of data management

The purpose of processing the registration is www.catecheticreativa.hu page content supervision, and notifying the registered persons about the up to date content.

4. Legal basis for data management

For the purposes of data processing indicated in point 3, Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC a) Data protection Regulation or GDPR) Article 6 (1), meaning, your consent .

Consent must be given after registration after entering the data using a checkbox .

5. Scope of data managed

The Author manages only the data to which the Data Subject has voluntarily consented.

The course registration mandatory information: name, username, email address, country. The secret password is known only to the WordPress content management system.

6. Duration of data management

The Author manages personal data until the withdrawal of consent by the Data Subject. Data Subjects may withdraw their consent to data processing at any time. The Data Subject may submit a request for the deletion or modification of the data from the database at any time by sending an e-mail to info@catecheticreativa.hu.

Withdrawal of consent also means the loss of the right to view and download protected content until the Data Subject re-registers.

7. The range of data accessors, data processors

The processing of personal data is realized by the Author, or by the Administrators empowered by the Author.

Personal data may only be displayed to the administrators of the website (the Author and the Administrators).

8. Rights of the data subject

8.1 Right to request information

You may request through the contact details provided in Section 1 that the Author informs you about the followings.

- what personal data the Author manages,
- on what legal basis,
- for what data management purpose,
- from what source,
- for how long and
- to whom, when, under what legislation, to which personal data was granted access by the Author, or to whom he transferred your personal data.

The Author or the Administrator will fulfill your request within a maximum of 30 days by sending a letter to the e-mail address you provided.

8.2 Modification (correction) and deletion of data

By logging in to the WordPress content management system, you can modify or supplement your inaccurate personal data, with the exception of your username, which can only be entered during registration. If you wish to change your username, please re-register and request the deletion of your incorrect user account via the contact provided in step 1.

You may, through the contact details specified in Section 1, request the deletion of your personal data in writing if their management is unlawful, if the purpose of data processing has ceased to exist, if the data subject has withdrawn his/her consent, if the deadline specified for data storing has expired, and, if it was ordered by a court or authority.

The Author or the Administrator will notify you of the rectification and deletion, as well as all those to whom the data has previously been transmitted for data management purposes. You will not be notified if this does not harm your legitimate interests for the purposes of data processing.

The Author or the Administrator shall not delete personal data if they are necessary for the submission, enforcement or protection of legal claims.

9. Remedies

In case of violation of your rights or if you do not agree with the Author's decision, you can file a complaint with the National Data Protection and Freedom of Information Authority:

In case of violation of rights, or if you don't agree with the decision of the Author, you may - within 30 days of the communication - directly seek remedy from the court having jurisdiction according to the Author's headquarters or domicile.

10. Data security

The Author shall ensure the protection of the security of data management with technical and organizational measures that provide a level of protection related to the data management in relation to the risks, select the IT tools used and operate in such a way that the processed data:

- be accessible to those entitled to it (availability);
- its authenticity and authentication are ensured (authenticity of data management);
- its invariability must be verifiable (data integrity);
- be accessible only to the authorized person, be protected against unauthorized access (data confidentiality)

The protection of the data managed are insured by the WordPress content management system.

11. Clause

The Author reserves the right to change its Privacy Policy. This may be the case, in particular, where required by law. A change in data management must not mean a different way of handling personal data. The Author shall publish the relevant information on its website 15 days in advance.
